Currently serve on 11 active graduate student committees in addition to my advisees, and served as first reader for 2 completed dissertations in 2011. I supervised 6 graduate teaching assistants during 2011.

## 3. Other Contributions to Instructional Programs

Director, Baird Center for Public Advocacy and Debate and Director of Forensics, A. Craig Baird Debate Forum. Responsible for supervision of the University's program of intercollegiate debate. I work intensively with outstanding students in an instructional role, which includes research direction, skills instruction, practice sessions, and tournament travel, coaching, and judging (8 three-day weekend tournaments in 2011). The students and coaches travel across the country, including events in California, Texas, and Georgia.

The intercollegiate debate program as a whole received national ranking in the top ten varsity programs between 1995 and 2001 and first in 1992 and 1999. Since 1987, 48 teams from the University of Iowa have qualified for the National Debate Tournament, the most prestigious national championship in intercollegiate policy debate. Of those, 23 have participated in the elimination rounds at that tournament. In 1996, the University team reached the final round of the National Debate Tournament. In March 2000, two Iowa debaters received the Rex Copeland Award at the National Debate Tournament. This award recognizes the team who has compiled the best overall record in national policy debate competition in the United States. In 2001, the University team won the National Debate Tournament. Ten students have earned top ten individual speaker awards at the last six NDTs, including first speaker at the 1992, 1997, and 2001 tournaments.

Organizer and moderator for the Iowa Public Debate program. I have prepared students and written introductions for, over 146 public debates since 1995, at least 5 per semester. In 2011, I organized and moderated 10 public debates. These debates are an integral part of the curricular experiences of students in the Rhetoric program and Communication Studies classes in argumentation. They serve as models of public speaking and oral advocacy for hundreds of students each year.

The Great Capital Debate. I organized, rehearsed, and moderated a historical debate between two graduate students in the Senate Chamber of the Old Capital Building on March 4, 2007 in connection with the 150<sup>th</sup> anniversary of the Iowa State Constitution. The program was a project of Willard (Sandy) Boyd, former UI President and Dean of the Law School, sponsored by the UI Museum and it was publicized in the Press-Citizen, the Daily Iowan, and the Gazette.

Director, Policy Debate Division, University of Iowa National Summer Institute in Forensics. In the summer of 2009, I organized the curriculum, supervised instructors, and worked closely with 15 outstanding high school debaters from across the country in a three-week summer program.

In 2011, I engaged in the following outreach efforts for high school and intercollegiate debate: participated as guest critic for the Southern Bell high school debate tournament at Montgomery Bell Academy, Nashville, TN, and the Blake School debate tournament in Minneapolis, MN. I served as policy tabulation director at the University of Kentucky National High School Tournament of Champions, and instructed college students in a two-week workshop near Arizona State University

whose profits fund Urban Debate League projects for minority high school students in southern California.

The Baird Debate Forum sponsors the A. Craig Baird Lincoln-Douglas Round Robin for 28 outstanding high school debaters from across the country. I assisted in the operation of the tournament and served as guest critic in April, 2011.

Iowa Debate Reunion 2010. I assisted in the direction and supervision and moderated several events, including a British international debate, for our October debate reunion, which brought back 40 alumni and family members for a two-day celebration of the A. Craig Baird Debate Forum.

A. Craig Baird Intercollegiate Debate Tournament. In December, 2011, the Forum hosted its second intercollegiate debate tournament in thirty years. Debate teams from 11 schools in the greater Midwest attended the tournament. I assisted in the direction and supervision of the event, and served as guest critic.
